This POLICY NOTICE is pursuant to and for the purposes of Article 13 of European Union General Data Protection Regulation 679/2016 ('GDPR') and Article 122 of the Italian Privacy Code.

Pursuant to and for the purposes of the provisions of Article 13 of European Union General Data Protection Regulation 679/2016 (hereinafter the 'GDPR') and Article 122 of the Italian Privacy Code, we hereby inform you that your personal data will be processed by electronic and manual means, in Italy and abroad.
