

CONDITIONS FOR REGISTRATION AND USE OF AN ACCOUNT

1. Object

The purpose of this document ("Terms of Registration and Use of an Account") is to define the terms and conditions under which Users may create an Account on [the www.mesaudacosmetics.it](http://www.mesaudacosmetics.it) website (the "Website").

"Account" means the Personal Area of the Company on which each User will be able to benefit from the services referred to in point 2 above (the "Services"). The availability of an Account is not a necessary requirement for the purchase of products on the Website. Acceptance of the relevant registration and use conditions is required for the creation of an Account.

2. The services available to account holders

Intelsis Srl (hereafter "Intelsis") owner and manager of the Website, offers to the users of the Website (the "Users") the opportunity to use the following services (the "Services") upon registration of a personal Account:

1. Manage User's registration data
2. Buy Mesauda Products available on the Website
3. Accept the general terms of sale for future purchases
4. Save or change shipping addresses to conclude purchases faster
5. Check past orders and see the history of previous orders
6. Join the "Mesauda Diamond Rewards " loyalty program
7. Invite a new participant through the "Introduce a friend" procedure
8. Make reviews about purchases

Intelsis reserves the right to add and/or remove any service by communicating them to Users on the Website and/or by email.

3. Account registration

- 3.1. In order to use the Services, the creation of the Account is required, with the acceptance of these conditions of creation and use of an Account.
- 3.2. Registration of the Account is free of charge. To create the Account, you must fill out the registration form by entering the required information and assure Intelsis that the information provided during the registration process is complete, correct and truthful.
- 3.3. To confirm the registration, an email will be sent to the address indicated at the registration stage asking to follow a specific confirmation procedure.
- 3.4. Login credentials are personal, cannot be transferred to third parties and must be kept confidential.
- 3.5. Any action performed through the Account is attributable to the User whom the login credentials are referred. Therefore, the resulting liability arising from unlawful actions will fall exclusively on the User and Intelsis will be held harmless.
- 3.6. The User acknowledges that Intelsis cannot be held responsible for the theft or abuse of login credentials by third parties that are not directly controllable.
- 3.7. If the User acknowledges acts of misuse of the contents of the reserved area by third parties, the User undertakes to notify Intelsis in a timely manner, so that the legal instruments suitable to safeguard the Users' and Intelsis' rights may be taken into account.

4. Code of conduct

4.1. The User undertakes to respect the following rules of conduct in the use of the Services and in particular in the drafting of reviews:

- a) do not make communications that cause harm to third parties or that violate applicable laws and regulations;
- b) do not publish material or communications with potentially offensive or otherwise unauthorized content from its owners;
- c) respect the principles governing public order and social security, avoiding the dissemination of messages, images or other material that may incite the fulfillment of crimes, the use of violence or violent acts, any form of participation or collaboration in illegal activities;
- d) do not use disrespectful language and/or material, much less turbulent and offensive, defamatory terms, including expressions of bigotry, racism, hatred, irreverence or threat;
- e) do not publish advertising or sponsorships even for a fee.

4.2. Intelsis reserves the right to verify any review entered by the Users prior to publication, and will have full right to decide at its own discretion not to make a review public or to remove it later.

5. Duration and Termination

5.1. The availability of the Account does not expire, but Intelsis reserves the right to revoke it at any time and without any prior notice, in the event that it is not used for a period of more than 12 months or if it is used fraudulently or incorrectly or harming intelsis or otherwise in the event of use in violation of these Conditions.

5.2. Users' or Intelsis' withdrawal of the Account result in the cancellation of the Account and in the loss of any benefit that may have been accumulated and not used. Intelsis reserves the right to request the return of any benefits (points, discounts, other) acquired unlawfully, as well as to take any legal action against the User.

6. Industrial and intellectual property rights

Intelsis holds all intellectual property rights to the contents of the site (e.g. texts, images, logos, videos, etc.) and, therefore, the User is prohibited from using, downloading, transmitting, selling or distributing, in whole or in part, the content and information available or received through the Website, without prior written permission from Intelsis.

7. Processing of personal data

The data you provided will be processed by Intelsis in accordance with the provisions of the European Regulation 2016/679 on the protection of personal data (GDPR), based on what is provided by the Privacy Policy of the Website.

8. Service Warning

Intelsis will do its best to provide Services as accurately as possible. However, Intelsis does not provide any guarantee, by way of example and not exhaustive, of the quality, proper functioning, absence of interruptions or suitability of the Services for a particular purpose or result set by the User.

9. Edit and update

These Terms may also be amended from time to time in consideration of any regulatory changes. Any changes to these conditions will be published on the Website and may be communicated by email to the User.

In case of conflicts between the Italian and English versions of this Regulation, the Italian version shall prevail.
